- Clear process and timeline, plus one page with priorities, guidance, submission info
- Broad participation: open calls, targeted outreach, accessible formats
- Thematic groups, not one forum
- Early clarity on priorities and non-starters
- Build on existing strategies and processes
- Clear criteria: OGP-relevant, ambitious, feasible, shared ownership
